



Informational Meeting On Controversial School Choice Law Tuesday Night

There's been an ongoing battle over Nevada's new school choice program and education savings accounts that are currently being disputed before the Nevada Supreme Court.

With the potential for an injunction to be lifted and the law officially enacted, many parents have questions about how school choice could affect them and their kids.

Bishop Manogue Catholic High School is hosting an informational meeting Tuesday night with several state experts on hand to answer questions.

"We just wanted to make sure we brought the experts to the town and have them here to quell that confusion for people," said Katie Hurst, Director of Admissions at Bishop Mangoue.

Tuesday's informational meeting starts at 6 p.m. inside the Small Gym of Manogue on the north side of the school. It is free and open to the public.

Nevada's school choice program was approved by the Nevada Legislature in 2015, but will see its last challenge in the Nevada Supreme Court on July 8, 2016. If approved, the state will start funding student's education savings accounts around \$5,000 annually.
